For the purposes of the provisions contained hereunder, "the School" shall mean or denote The Red & Yellow School. "You" and "Student" shall mean or denote the student and/or the parent/guardian as the case may be and unless the context clearly indicates otherwise.

1. GENERAL

1.1. As a student at the Red & Yellow, you shall at all times maintain a high standard of behaviour and academic diligence, that adhere to the School's code of conduct and student policies, and not conduct yourself in a manner which causes prejudice to or brings the name of the School into disrepute.

1.2. You acknowledge that you have familiarised yourself with the prospectus of the relevant programme for which you have applied to register and declare that the information provided in this form is accurate and complete.

1.3. You accept that the School reserves the right to monitor your attendance and in the case of your extended absence due to illness or injury, you will be required to submit a medical certificate.

1.4. You accept responsibility for the replacement or repair of any damage or loss caused by you to the property of the School. You accept that the School is not responsible for lost or stolen property and that any of your personal belongings brought onto the premises should be insured in your personal capacity. You hereby indemnify the School against any claim in this regard.

1.5. When you participate in School activities, including external visits which may take place from time to time, it shall be at your own risk. 1.8. 2. DEPOSITS, FEES, METHODS OF PAYMENT

2.1 Upon written acceptance of a student to study at the School a non-refundable registration fee is required for each programme. The final date for such registration and payment of the registration fees for the 2024 School year is 31 January 2024. Students who have not paid their fees by this date will not be eligible to start their studies in February 2024.

2.2 This registration fee is to reserve your place in the programme and will be forfeited should you elect not to attend. Note: The non-refundable registration fee does not form part of the tuition fees.

2.3. Should you elect not to continue or complete your studies, withdraw or have your enrolment or registration terminated for any reason whatsoever, you will be liable for (a) 50% of your course fees if this happens in the first Semester; and (b) 100% of your course fees if this happens in the second Semester.

2.4. Where your tuition fees are payable in instalments, your failure to pay any single instalment in full and timeously will result in the full amount owing becoming due and payable immediately.

2.5. You agree that the School shall be entitled to recover from you all legal costs incurred in order to enforce its rights under this contract, including, but not by way of limitation, attorneys and own client fees and collection charges and all tracing charges, and that the School reserves the right to withhold programme/module results should there be any default in payments according to this agreement.

2.6 The Red & Yellow School is a privately run institution and receives no state funding. The majority of income is generated by student fees, corporate-sponsored bursaries and remunerations from commissioned projects.

2.7. In the event that the student elects to make payment via two or ten instalments, the School at its absolute discretion may require additional personal information before approving plan and acceptance by the School of this application shall be subject to such provision and its acceptability thereof and also may require the person responsible for the Student's account to sign a debit order mandate.

3. PERSONAL INFORMATION

3.1. In terms of the Protection of Personal Information Act 4 of 2013 (POPI), a "Responsible Party" (the School) has a legal duty to process a "Data Subject's" Personal Information (your personal information) in a lawful, legitimate and responsible manner.
