Section 2

Terms and conditions of application

For the purposes of the provisions contained hereunder, “the School” shall mean or denote The Red & Yellow School. “I” and “Student” shall mean or denote the student and/or the parent/guardian as the case may be and unless the context clearly indicates otherwise

1. General

1.1. As a student at the Red & Yellow School, I shall at all times maintain a high standard of behaviour and academic diligence and shall not conduct myself in a manner which causes prejudice to or brings the name of the School into disrepute.

1.2. I accept that the School reserves the right to monitor my attendance and in the case of my extended absence (more than two consecutive days) due to illness or injury, I will be required to submit a medical certificate.

1.3. I shall at all times comply with my financial obligations to the School in accordance with the provisions of this application.

1.4. I confirm that I am in a state of good mental health and that I or my guardian shall fully disclose to the School details of any condition/disease/handicap immediately upon becoming aware of the same. The School shall treat any such disclosure as being confidential.

1.5. All/any work originated and/or undertaken by me during the period of my registration at the School and all/any intellectual property rights related thereto shall be deemed to be the property of the School. I hereby cede all my rights, title and interest in and to such work and such aforesaid intellectual property rights to the School. The School reserves the right to cede, reassign or otherwise deal with these rights at its discretion.

1.6. I accept that the School shall from time to time undertake assignments from outside companies, and that I may be requested, as part of my training, to work on these assignments. I accept that the School shall be entitled to charge professional fees for these assignments and that I shall not be entitled to financial remuneration for my participation. I accept that all such work is highly confidential and will not be disclosed outside of the School.

1.7. I understand that a qualification related to my completion of any Programme at the School shall be awarded to me only if I have met the required academic standard and evaluation criteria of the School. And only if I have fulfilled my financial obligations in terms of this application

In accordance with the above, the School expressly reserves its right to withhold any such qualification until all the financial obligations referred to have been properly fulfilled.

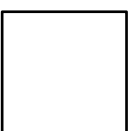
2. Deposits, fees, method of payment

2.1. The final date for registration and payment of the application acceptance fee for the programme is due the Friday before the programme commences. Students who have not paid their fees by this date will not be eligible to start their studies

2.2. Upon written acceptance of a student to study with Red & Yellow a non-refundable application acceptance fee is required for each programme to secure the spot..

2.3 This application acceptance fee is to reserve your place in the programme and will be forfeited should you elect not to attend. Note: The non-refundable fee does not form part of the tuition fees.

2.4 For 1 year programmes: should you withdraw from the programme for any reason: during the first or second term, you will be liable for 50% of the full year fees; at any time after the commencement of the third term, you will be liable for 100% of the full year fee. **For 2 year programmes:** Should you withdraw from the programme for any reason: during the first year, you will be liable for 50% of the full year fees; at any time after the commencement of the second year, you be liable for 100% of the full programme fee
